I hereby donate to the **South East Reined Cow Horse Association**, hereafter in this document known as **SERCHA**, one breeding to a designated mare by my stallion _____, for the breeding year **2009**.

This **SERCHA** Breeding Contract is transferable to a mare owner who is the high bidder at a silent, sealed bid auction held by **SERCHA** beginning January 12 and ending midnight February 26, 2009.

The stallion owner/agent shall supply the appropriate documentation to facilitate the registration of the resulting foal according to the appropriate breed registry. For Private Treaty fees contact the **SERCHA** office. Only one embryo transfer will be recognized per contract. In the case of frozen semen, the same rules apply as a live stallion breeding donation, as long as semen is viable. A live foal is guaranteed only to the extent of a return breeding (the same or a substitute mare) the following year, and then only by the initial owner of this contract. Any mare care charges, accidents, illness, or any mishap concerning the mare named in this contract are the responsibility of the mare owner.

A mare owner shall contact stallion owner/agent and be responsible for any and all charges/fees related to execution of this contract. SERCHA is not responsible for any costs, expenses, or charges relative to execution of breeding contract by the breeding facility not contained or recorded in this contract. There will be no refunds.

SERCHA's involvement in, and responsibility for, terminates, except as otherwise provided in this agreement, upon the transfer of breeding to the mare owner. The 2009 breeding fee for this stallion is \$ _____ (US Funds)

Stallion owner/agent, mare owner/agent and **SERCHA** stipulate that all terms and conditions of this contract will be construed and interpreted according to the laws of the State of Louisiana.
